Personal data that in his case can request of you:

Said "Application" will have to contain the following information: complete name; email to receive notifications; simple copy of the official identification with photography, clear and precise description of the Personal Data concerning which look for to exert some of the Right ARCH; any element or document that facilitate the location of his Personal Data; and signature of the "Application" of you.

In case that the "Application" make through legal representation, will have to present public instrument or letter can signed in front of two witnesses, in his

case, properly signed and with copy of identification of this last.

In case to request the exercise of the right of: Rectification, will have to indicate the modifications to make and provide the documentation that accredit and sustente the request; and Access; "Fertility Clinic Americas" will provide the Personal Data via email and/or by means of appointment on the dot available and/or corporate offices, to election of "Fertility Clinic Americas".

Time of answer:

In case to result pertinent his "Application", "Fertility Clinic Americas" will have to do it effective inside the 15 skillful days following, explained from the reception via email of the origin of his "Application".

Listing of Exclusion:

In addition, to the procedure for the exercise of the Right ARCH, you has right, in regard to the Secondary Ends to: revoke or manifest his refusal to treat his Personal Data; and/or be included in the "Listing of Exclusion" enabled and typical of "Fertility Clinic Americas" that it allows us limit the use and divulging

of Personal Data. For both effects suffices send us, the application to revoke or be excluded, which will have to contain: complete name; and account of email to answer his application, is will have to be headed to our Department of Personal Data protection to the following email avisodeprivacidad@fcamericas.com, having to receive accuse of receipt so that "Fertility Clinic Americas" remain linked in this regard.
